Johnson Controls expands TYCO® Rapid Seal Adapter product line with the addition of seven new fittings; design improvements made to existing fittings

Johnson Controls is pleased to announce the addition of seven new sprinkler head adapters/fittings to its industry-leading Tyco Rapid Seal Adapter (RSA) product line. Featuring an all-CPVC design, RSAs eliminate the need for sprinkler thread tape and sealant, thereby reducing installation time. In addition to expanding the product line, Johnson Controls optimized the design of our current portfolio of RSAs to improve ease of installation and combined two of the fittings into one design.

The seven new fittings will be available for sale beginning August 25th while the four redesigned replacement fittings will be phased in over the coming weeks as existing RSA inventory is depleted. Customers should order using the following part numbers until further notice.



Transition from Existing to Redesigned Replacement Fittings

- As inventories of the existing RSAs are depleted and phase-in of the redesigned replacement fittings begins, customer service representatives will inform customers if their order will be fulfilled with the replacement fittings. Customers will be consulted on any orders that contain a mix of existing and replacement fittings.
- There will be no interruption in product availability.
- The redesigned replacement fittings are a direct replacement in application for the existing Rapid Seal Adapters sold by Johnson Controls today. A technical services letter is available upon request should it be needed to present to an Authority Having Jurisdiction (AHJ).
- In an effort to expedite phase-out of the existing RSA parts, we will adhere to a strict return policy. We will not accept customer returns of existing RSAs for the reason of wanting new parts.
- The redesigned replacement fittings will be priced the same as the fittings they are replacing.
